AND WHEREAS the TRUSTEES here to have given their consent to be the Trustees along with the settlor Trustee for administering the affairs of the Trust in accordance with the terms and conditions herein after provided:

NOW THIS DEED OF TRUST WITNESSETH as follows:-

- The Name of the Trust shall be "SATYAM EDUCATIONAL,
 HEALTH AND CHARITABLE TRUST".
- 2) The office of the Trust shall be located at J-189, P.C. Colony, Kankarbagh, Patna – 800020 or at such other place or places as the Trustees may from time to time deem fit.
- 3) THE AIMS AND OBJECTS OF THE TRUST ARE as follows:-
 - a) To establish, develop, maintain and run educational institution of all types, of any discipline and to promote the cultural unity, Social activity and help those who have suffered in disasters or natural calamities,
 - b) To establish, maintain and run studentship, scholarships and render other kinds of aid to the students of any discipline,
 - c) To establish and run institution for Promotion of Science and Technology, literature, music, dance, drama and fine arts,
 - d) To establish and run schools hospitals, Nursing Homes and diagnostic Centres, Dental Colleges, Medical Colleges, Engineering Colleges, Nurses training college, B.Ed. College, Polytechnic College and all other professional or vocational training institutions

- To undertake the activities of preventive and Social Medicines and / or Community medicines.
- f) To research, develop, manufacture, import and export and to carry out distribution of medicines e.g. allopathic, Homeopathic, Ayurvidee and herbal.
- g) To run and maintenance of the important memorial and other places which have historical, Cultural and spiritual importance.
- To develop import, export and manufacture of diagnostic tools and technologies.
- To carry out the activities relating to food processing, agriculture as well as agriculture research, sericulture, horticulture and cultivation of Ayurvedic and herbal medicinal plants.
- To establish, maintain or arrange grants to organization, asharma or institutions to conduct such activities like.
 - i) Prohibition
 - ii) Communal Harmony
 - iii) Removal of Untouchability
 - iv) Uplift of women and children
 - v) Drinking Water
 - vi) Welfare of SC and ST people.
- k) To establish and maintain park for preservation of flora and fauna, gymnasium, sports club, dharmshala, rest houses for use by public in general.
- To establish and run homes for the aged, orphans or others establishments for the relief and help to the poor needy and destitute people.

- m) To help the persons, organizations, corporate bodies or any type of public or private body engaged in similar activities as mentioned above or any other activities of public welfare.
- To carry out other incidental activities for achieving the objects mentioned herein above.
- To promote international understanding by maintaining relationship with educational organizations and institution or the government of the foreign countries.
- p) To spread the massage of our epic or other religious books like Vedas, Upanishad, The Ramayana, The Guru Granth Sahib, The Bible, The Kuran etc.
- 4. MANAGEMENT OF THE TRUST.
- A) This Trust shall be managed by a Board of Trustees headed by Mangaing Trustees.
- B) THE MANAGING TRUSTEE of this Board shall hold office for life time and shall carry on the affairs of the Trust with the support of the Board of Trustees.
- C) All the Trustees shall hold office of the Trusteeship and their post in the executive body for their life or till they desire to continue. In case they want to relinquish, they will have the power to nominate one of their direct legal heir/ any person to be appointed in their place. In case of sudden death of a Trustees, his / her post will be filled up as "registered will" executed by him/her
- D) In case of any dispute or conflict in taking any decision among the Board of Trustees, the decision of the Managing Trustees-will be final.



- E) When a Trustee ceases to be a Trustee (death / retirement or otherwise) a new Trustee shall be elected by the Managing Trustees with the support of the Board of Trustee.
- F) A Trustee who does not act in conformity with intention of the execution in letter and spirit, as expressed in this deed or is otherwise unfit to hold the office, shall be removed by the Board after the approval of the Managing Trustee.
- G) The post of the Managing Trustee will be held by the concerned Trustees for his life or till such Trustee desires to continue. Shri Shankar Kumar, Managing Trustees, son of Shri Bangali Singh, resident of J-189, P.C. Colony, Kankarbagh, Patna 800020 shall be the Managing Trustee of the Trust for life or till he wishes to continue. In case he wishes to relinquish his respective posts, he will have right to nominate any person to hold his post. In case of sudden death of the Managing Trustee his post will be filled up as per term and conditions laid down in his 'registered will'.
- II) All the executive and administrative powers shall be vested in the Managing Trustee and the same may be delegated by him to other Trustee in writing for a period decided by the Managing Trustee.
- All the bank accounts of the Trust will be operated by the Managing Trustee of the Trust.
- The Trust will apply whole/ part of the income of the Trust fund or accumulation as hereto any one or more of the objectives of the Trust.
- K) The Trust will accept any donation, contribution and grant from any person, persons and organization etc.

- L) The Trust will act through resolutions taken by the Board of Trustees passed by mutual consent. If it is not possible then by simple majority in order to achieve the aims and objectives of the Trust in conformity with Indian Trust Act and other law of the land in force.
- M) Any amendment can be made in the terms and conditions, objectives and aims and titled of this present deed, except for some, can be passed by the 2/3rd majority of the Trustees. Such amendment will come into effect after the signature of the Managing Trustee.
- N) The Trust shall be empowered to take over or amalgamate with any other charitable Trust, society, association or institution with similar objects.
- O) The Trustees may from time to time form frame rules for conduct and regulations of the meeting of Trustees. In absence f such regulation one third (1/3rd) of the Trustees shall form the quorum of the meeting. All the meetings of the Trustees shall be called by the Managing Trustee of the Trust and will be attended by him.
- P) Annual accounts of the Trust shall be regularly maintained and audited by a Chartered Accountant every year. The accounting year of the Trust shall be from 1st April to 31st March every year.
